

LAST WILL AND TESTAMENT

OF

LINDA H. BURNETT



I, LINDA H. BURNETT, a resident of Jefferson County, Kentucky, being of legal age, sound mind and disposing memory do hereby make, publish and declare this to be my Last Will and Testament, hereby revoking any and all Wills and Codicils thereto, heretofore made by me.

ITEM I

I direct that all my just debts and my funeral expenses be paid as soon as practicable after my death. In the event any property or interest in property passing under this Will or by operation of law or otherwise by reason of death shall be encumbered by a mortgage or lien or shall be pledged to secure an obligation (whether the property so encumbered or pledged shall be owned by me jointly or individually), it is my intention that such indebtedness shall not be charged to or paid from my estate, but that the devisee, legatee, joint owner taking by survivorship, or beneficiary shall take such property or interest in property subject to all encumbrances existing at the time of my death.

ITEM II

All inheritance, estate and succession taxes, including interest and penalties payable by reason of my death shall be paid

Syes MONE out of and be charged generally against the principal of my residuary estate, without reimbursement from any person.

ITEM III

I give, devise and bequeath to my grandchildren all life insurance policies that are payable to my estate. That said amounts shall be divided equally between any and all grandchildren at the date of my death.

ITEM IV

I give, devise and bequeath all the rest, residue and remainder of my estate, real, personal and mixed, tangible and intangible, wheresoever situated and of whatever nature to my children, TERESA A. EILMAN, JAMES A. EILMAN and LINDA F. EILMAN, per stirpes, absolutely and in fee simple, of which I may die possessed or over which I may have the right of disposition at the time of my death.

ITEM V

I name, constitute and appoint my daughter, TERESA A. EILMAN, Executrix of this my Last Will and Testament, and request that she be permitted to serve without surety on her bond. I give my Executrix the full right and power to compromise any and all claims

RO.M. and liabilities of my estate, the power to convey, sell, mortgage or rent any of the property, either real or personal, the power to execute all papers and instruments necessarily required to do the aforesaid, and my Executrix shall not be required to have a Court order to sell any of my estate.

In the event my daughter, TERESA A. EILMAN, predeceases me or cannot for any reason serve as my Executrix, then and in that event, I name, constitute and appoint my daughter, LINDA F. EILMAN, as Executrix of my estate, she to have the same power and authority as hereinabove set forth.

ITEM VI

I further desire and request that my family and my personal representative be required to cremate my body and dispose of my ashes appropriately.
