This Court, being fully advised in premises and for good cause shown, hereby ORDERS the following:

Defendants Sue Scheff and PURE, Inc. shall turn over all computers in her possession and control ("Computers") to NDB Associates ("Experts") located at 7900 Glades Road, Suite 300, Boca Raton, Florida by 5:00 pm EST on Tuesday, March 16, 2004.

Defendant Jeff Berryman shall turn over all computers (also "Computers") in his possession and control at a time and a place to be determined by the parties.

Before the computers will be turned over to Experts, Experts shall sign an agreement



acknowledging receipt of this Order and shall consent to abide by its terms and submit to the jurisdiction of this court for any breach of the agreement.

Experts shall make two mirror-images of the Computers. One mirror-image shall be sent to Henriksen & Henriksen, 320 South 500 East, Salt Lake City, Utah 84102. The other mirror-image shall be retained by Experts.

All documents, materials, data and information retrieved or copied from the Computers shall be produced to Henriksen & Henriksen, 320 South 500 East, Salt Lake City, Utah 84102 in a CD format and should be able to be opened and read on a standard PC. If these documents and files cannot be opened and read by standard computer software, Experts shall provide any specialized software or equipment necessary for viewing this information.

Henriksen & Henriksen shall have five business days from the time of delivery to review such documents, materials, data and information received from Experts to determine whether such documents, materials, data and information contain privileged, confidential or irrelevant information.

Henriksen & Henriksen shall then produce all such documents, materials, data and information to plaintiff with the exception of any materials deemed privileged, confidential or irrelevant.

With respect to any materials deemed privileged, confidential or irrelevant, Henriksen & Henriksen shall produce a log in compliance with the eight factors set forth in this Court's order of March 11, 2004. Such log must be produced within ten (10) business days of the production of all such documents, materials, data and information by Experts or any privilege or objection to production shall be deemed waived.

Following termination of this matter by settlement, verdict or final judgment the mirror-image in the possession of Experts shall be destroyed or produced to Henriksen & Henriksen, 320 South 500 East, Salt Lake City, Utah 84102.

Experts are expressly ordered to not discuss with anyone, including parties and counsel to this action, any of the documents, materials, data or information obtained or retrieved from the Computers. This restriction is intended to prohibit the disclosure of privileged information.

Should Experts believe that the documents, materials, data or information on the Computers has been tampered with, Experts shall disclose such belief to counsel for both parties without revealing which documents may have been tampered with until such documents may be reviewed for privileged material.
